WHEREAS, the low dollar compliant bids for ITEMS 2 & 5 were received from Charles Gabus Ford, 4545 Merle Hay Road, Des Moines, IA 50310, Gene Gabus, President, at a total cost of \$109,746.00; and

WHEREAS, the low dollar compliant bid for ITEM 3 was received from Stivers Ford, 1450 E. Hickman Road, Waukee, IA 5050263, Scott Politte, General Manager, at a total cost of \$31,348.00; and

WHEREAS, the low dollar compliant bids for ITEM 4 was received from Stew Hanson Dodge City, 12103 Hickman Road, Urbandale, IA 50322, Dan Boetcher, General Manager, at a total cost of \$29,945.00; and


