WHEREAS, the Procurement Division solicited bids by advertisement and mailing Invitation to Bid V15-133 to eight (8) potential bidders with two (2) bids received; and

WHEREAS, the low dollar compliant bid was received from Keltec Inc., 205 N. High Street, Baxter, IA 50028, Kelly Milligan, President; and

WHEREAS, funding is available from PD001351/Planning & Budget, for an annual estimated cost of \$40,000.00; and

WHEREAS, the Procurement Administrator and the Police Department recommend approval of the low dollar compliant bid from Keltec Inc.;

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the award to Keltec Inc. to furnish prisoner transport containment systems and shotgun mounts for an annual estimated amount of \$40,000.00, and further authorizes the Procurement Administrator to enter into an annual agreement renewable for two (2) additional twelve (12) month periods, with price increases complying with agreement terms.
