WHEREAS, the Procurement Administrator and the Public Works Department recommend approval of the low dollar compliant bid from Liberty Ready Mix;

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the award to Liberty Ready Mix for an annual estimated amount of \$75,000.00, and further authorizes the Procurement Administrator to enter into an annual agreement renewable for two (2) additional twelve (12) month periods, with price increases complying with agreement terms.
