Proposed vacation and conveyance of Carpenter Avenue, 27th Street and alley right-of-way

City of Des Moines City Council:

Please accept this request to waive the three required readings of the ordinance to vacate the above referenced City-owned right-of-way. This will enable to Drake University to prepare the faculty, students and staff for changes in traffic and parking patterns prior to the beginning of the academic year in August. In order to mitigate disruption, signage and communications about the changes, should be in place prior to students returning to campus. Students begin moving in to the dorms beginning in early August and, once they have arrived and moved in, it becomes difficult to change traffic patterns and parking habits.

The construction of two new academic buildings will begin later in the fall semester. There is, however, preconstruction work that needs to begin this summer. This work includes replacement of a communication duct and the movement of a high voltage electrical distribution lines in the area of the future construction.
