# APPROVING COMPLETION AND ACCEPTANCE OF THE PRIVATE CONSTRUCTION CONTRACT FOR SKYWALK IMPROVEMENTS, 801 GRAND AVENUE, BETWEEN GTG CONSTRUCTION, LLC AND PRINCIPAL LIFE INSURANCE COMPANY

WHEREAS, on June 23, 2014 under Roll Call No. 14-0935, the City Council approved a private construction contract in the amount of \$109,848.00, between GTG Construction, LLC, Steven G. Grasso, Managing Partner, 6505 Merle Hay Road, Suite A, Johnston, IA, 50131 - as Contractor, and Principal Life Insurance Company, Larry Zimpleman, Chairman, President, 711 High Street, Des Moines, IA, 50392 - as Owner, for construction of Skywalk Improvements described as including electrical upgrades, mechanical controls, commissioning, testing and balancing, and interior finish upgrades in the skywalks from the High Street Skywalk to the Grand Avenue Skywalk that are from Principal 801 Grand Avenue, all in accordance with the contract documents, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.

NOW THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the attached report of the Des Moines City Engineer acknowledging the completion and recommending the acceptance of the construction of said Skywalk Improvements in the amount of \$109,848.00, which have been constructed in substantial compliance with the contract documents between GTG Construction, LLC and Principal Life Insurance Company, which were approved under Roll Call No. 14-0935, dated June 23, 2014, be received and filed; and that completion of said Skywalk Improvements described as including electrical upgrades, mechanical controls, commissioning, testing and balancing, and interior finish upgrades in the skywalks from the High Street Skywalk to the Grand Avenue Skywalk that are from Principal 801 Grand Avenue, all in accordance with the contract documents, is hereby acknowledged and that said Skywalk Improvements are hereby accepted.


