AGENDA HEADING:

Amending Chapter 114 of the Municipal Code regarding traffic regulation changes to Snow Routes to reflect DART bus routes.

SYNOPSIS:

During snow and ice control operations, Public Works first plows hospital access routes, followed by snow routes, then to residential routes. Snow routes are planned to provide access to residents within a few blocks of their driveway. They are determined by the following criteria;

- On Federal Aid Eligible (FAE) streets identified as “Collectors” or “Arterials”;
- On streets with Des Moines Area Rapid Transit (DART) routes; and
- Within approximately four (4) blocks of a residence.

These changes will update the snow routes to reflect the current DART routes and new development on the southeast side of the City.

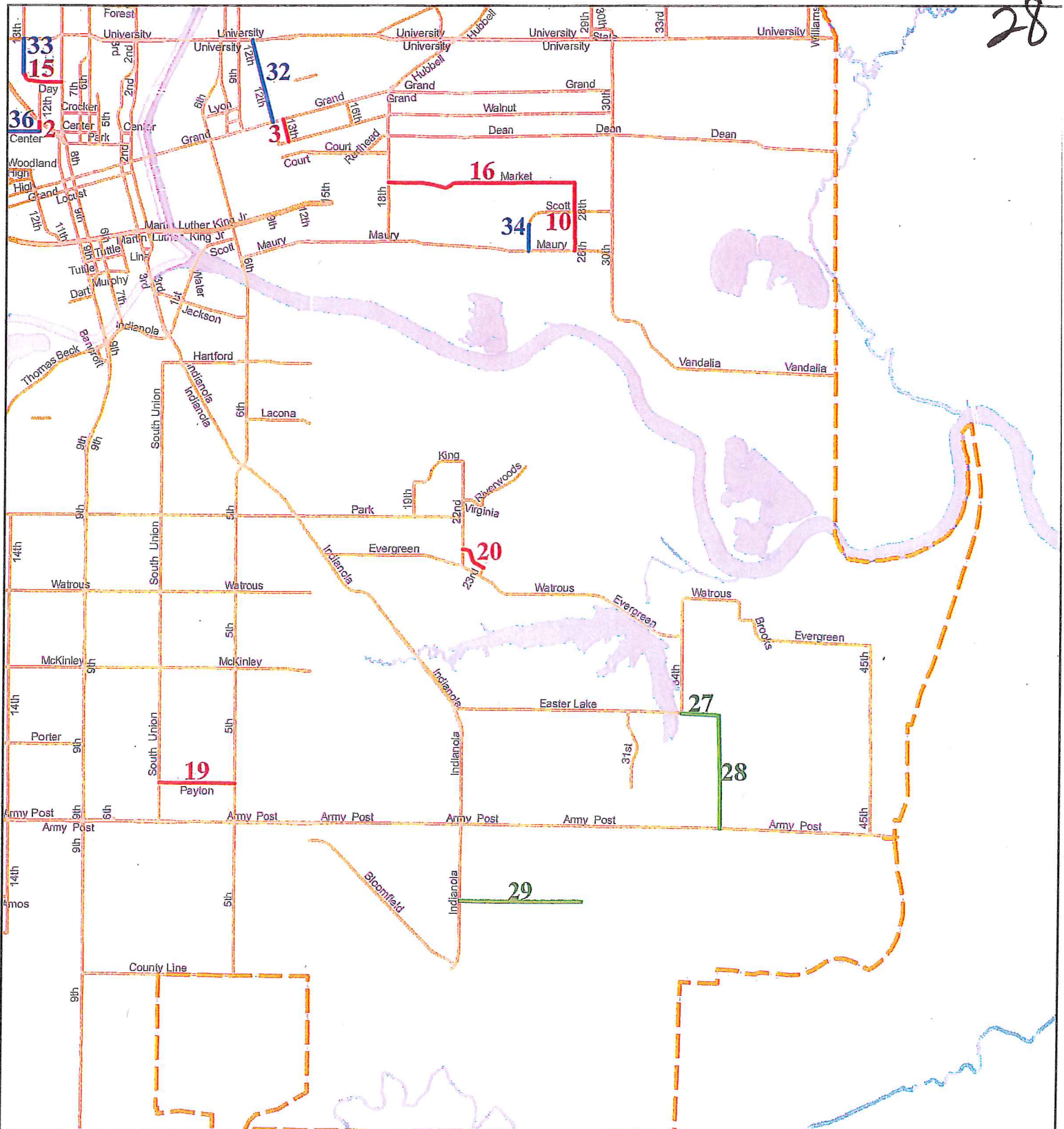
