APPROVING ASSIGNMENT OF LEASE FOR PROPERTY LOCATED AT 1618 6TH AVENUE TO IMPACT COMMUNITY ACTION PARTNERSHIP

WHEREAS, the City of Des Moines through its Community Development Department operates Community Services site offices throughout the City to provide a variety of services to low income families; and

WHEREAS, IMPACT Community Action Partnership ("IMPACT" formerly known as Red Rock Area Community Action Program or "Red Rock") provides community action agency programs to a large geographical area surrounding the City of Des Moines, including all other areas of Polk County, Boone, Jasper, Marion and Warren Counties; and

WHEREAS, on October 6, 2014, by Roll Call No. 14-1601, the City Council of the City of Des Moines, Iowa, authorized the City Manager to enter into formal discussions to evaluate the provision of Community Action Agency Programs in the City of Des Moines by IMPACT; and

WHEREAS, on January 26, 2015, by Roll Call No. 15-0145, the City Council of the City of Des Moines, Iowa, authorized the City Manager and Legal Department to negotiate an agreement with IMPACT in anticipation of IMPACT assuming Community Action Agency programs and services in Des Moines; and

WHEREAS, on May 18, 2015 by Roll Call No. 15-0871, the City Council of the City of Des Moines, Iowa, approved an agreement with IMPACT to assume the obligations of the City's Community Action Agency; and

WHEREAS, on September 22, 2008, by Roll Call No. 08-1672, the City Council of the City of Des Moines, Iowa, approved a Commercial Lease Agreement with Neighborhood Development Corporation on behalf of the Community Development Department for property located at 1618 6th Avenue; and

WHEREAS, on June 9, 2014, by Roll Call No. 14-0860, the City Council of the City of Des Moines, Iowa, approved a Lease Amendment to lease additional space to accommodate administrative staff formerly located at East Euclid Avenue; and

WHEREAS, said Lease Amendment extended the term of the original Commercial Lease Agreement through October 31, 2018.
