RESOLUTION FIXING DATE FOR PUBLIC HEARING ON THE PROPOSITION TO AUTHORIZE A LEASE AGREEMENT BETWEEN THE CITY OF DES MOINES AND MURPHY TRACTOR AND EQUIPMENT COMPANY FOR THE RENTAL OF UP TO FOUR MOTOR GRADERS FOR A FOUR-MONTH PERIOD AND FOR PROVIDING FOR PUBLICATION OF NOTICE THEREOF

WHEREAS, it is deemed necessary and advisable that the City of Des Moines, Iowa, should enter into a Lease Agreement for the rental of up to four motor graders to be used at the Department of Public Works, said lease to be for an approximately four-month period and said lease calls for monthly payments of \$4,950 for each motor grader plus fees and other charges, including excess hourly charges, as authorized by Section 364.4 and 384.25 of the Code of Iowa; and

WHEREAS, the Lease Agreement shall be payable from the general fund; and

WHEREAS, before the Lease Agreement may be authorized, it is necessary to comply with the provisions of the Code of Iowa, as amended, and to publish a notice of the proposal and of the time and place of the meeting at which the City Council proposes to take action for the authorization of the Lease Agreement and to receive oral and written objections from any resident or property owner of the City to such action.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City Of Des Moines, Iowa:

Section 1. That the City Council meet in the Council Chambers, City Hall, Des Moines, Iowa, at 5:00 o'clock P.M., on the 23rd day of November, 2015, for the purpose of taking action at a public hearing on the matter of the authorization of a Lease Agreement between the City of Des Moines and Murphy Tractor and Equipment Company, for the rental of up to four motor graders for the removal of snow, said lease to be for an approximately four-month period and said lease calls for monthly lease payments of \$4,950 for each motor grader (with a total rental amount of up to \$79,200 plus fees and other charges including excess hourly charges) to be used by the Department of Public Works.

Section 2. That the City Clerk is hereby directed to cause a publication to be made of a notice of said public hearing in a legal newspaper, printed wholly in the English language, not less than four clear days nor more than twenty days before the date of said public hearing on the authorization of said Lease Agreement.

Section 3. The notice of the proposed action to authorize said Lease Agreement shall be in substantially the following form:
