**APPROVING THE SUBMISSION OF THE 2015 U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) CONTINUUM OF CARE APPLICATION**

WHEREAS, in response to a Notice of Funding Availability (NOFA) for Continuum of Care Grants published in the Federal Register to supplement funding for local homeless programs, the Polk County Iowa Continuum of Care Board prepared a Continuum of Care application for \$3,357,079 in Continuum of Care funds to be submitted to HUD for funding approval; and

WHEREAS, at its meeting on November 2, 2015, Polk County Continuum of Care Board received and recommended approval of the Continuum of Care Grant Committee's recommendations for the 2015 Continuum of Care Grant application; and

WHEREAS, the application is based upon the Continuum of Care strategy, whereby Continuum of Care funds would provide needed services to homeless persons in Des Moines and throughout Polk County and address high priority service gaps within the parameters of the priorities and procedures recommended by the Polk County Continuum of Care Board.

NOW, THEREFORE BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the above referenced Continuum of Care program application and certifications thereto are hereby approved and ratified, and the City Manager or his designee is hereby directed to execute any necessary documents and submit the application to HUD.
