**APPROVAL OF THE ADVANCE OF FUNDS TO THE METRO CENTER
URBAN RENEWAL PROJECT FOR PLANNING, OVERSIGHT AND ADMINISTRATION**

WHEREAS, on March 20, 2000, by Roll Call Nos. 00-788 and 00-789, the City Council adopted the Urban Renewal Plan for the Metro Center Urban Renewal Project and such Plan has been amended seventeen times; and

WHEREAS, the Metro Center Urban Renewal Project Area encompasses an irregularly-shaped area that includes the downtown core and the areas surrounding the downtown core which is appropriate for expansion as a retail, financial, business, administrative, governmental, housing and cultural center of the Des Moines metropolitan area; and

WHEREAS, the Metro Center Urban Renewal Project requires ongoing planning, oversight and administration through assigned City staff, City Legal Department staff and other available resources to achieve the Urban Renewal Plan objectives for elimination of slum and blighted conditions, economic development, land use, traffic and circulation, housing and historic preservation; and

WHEREAS, the planning, oversight and administration of the Metro Center Urban Renewal Project is an urban renewal project that includes, but is not limited to, continuing planning to assess and respond to the problems, needs and opportunities of the project area, preparing land for a redevelopment, soliciting development proposals and negotiating with prospective developers, drafting and preparation of urban renewal and economic development agreements and other related contractual documents, enforcement of contractual documents, legal work relating to land acquisition and disposition, drafting of documents and proceedings for use of tax increment revenues, supporting efforts to rehabilitate structures, establishing and enforcing land use requirements for redevelopers, planning and programming to assure the provision of adequate parking, assisting the provision, maintenance, improvement and repair of public improvements and the soliciting, packaging and administering of economic development proposals; and

WHEREAS, the City has advanced \$750,000 of general funds to pay for a portion of the costs and expenses relating to the planning, oversight and administration of the Metro Center Urban Renewal Project in fiscal year 2015/16.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the advance of \$750,000 of funds necessary to pay a portion of the costs and expenses for the urban renewal project of planning, oversight and administration of the Metro Center Urban Renewal Project in fiscal year 2015/16 is hereby approved.
