WHEREAS, Beaver, Berkley, Bouton, Boxholm, Dallas Center, Dana, Grand Junction, Granger, Grimes, Johnston, Minburn, Ogden, Perry, Urbandale, Woodward, Boone County Soil and Water Conservation District, Dallas County Soil and Water Conservation District, Greene County Soil and Water Conservation District, Polk County Soil and Water Conservation District, Webster County Soil and Water Conservation District, Boone County, Dallas County, Greene County, Polk County, and Webster County desire to enter into a 28E agreement to create a Watershed Management Authority entitled Beaver Creek Watershed Management Authority; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF Des Moines, Iowa, that the 28E Agreement with the various entities for the Beaver Creek Watershed Authority Agreement, is on file with the City Clerk and is hereby approved and the Mayor and City Clerk are hereby authorized and directed to execute and attest respectively said agreement for and on behalf of the City of Des Moines, Iowa.

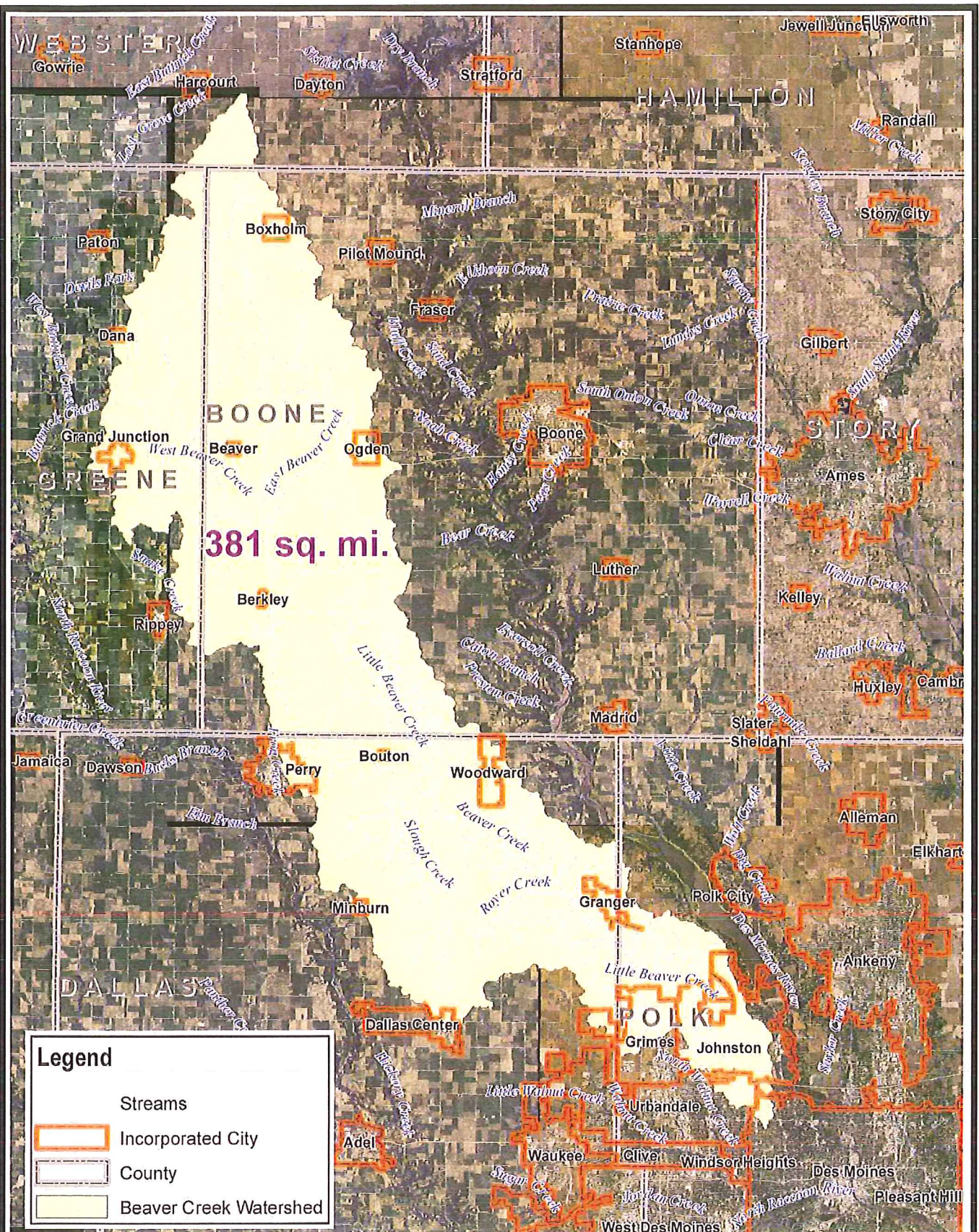

**Legend**

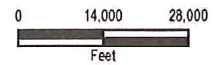
- Streams
