AGENDA HEADING:

Amending Chapter 114 of the Municipal Code Regarding Traffic Regulation Changes as follows:

- A. On-street parking restriction change Grand Avenue from 5th Avenue to 6th Avenue
- B. On-street parking restriction change Walnut Street from 13th Street to 15th Street
- C. Codes changes related to the construction of Bill Reichardt Way

SYNOPSIS:

Recommend approval of the staff recommendations, including first reading of the ordinance regarding the traffic regulation changes.

ADDITIONAL INFORMATION:

A. On-street parking on Grand Avenue between 5th Avenue and 6th Avenue was reviewed with the opening of the Wellmark YMCA. The following changes are necessary to provide passenger loading and accessible parking near the entrance to the YMCA. The following ordinance changes will place these parking changes into effect.

Sec. 114-3248. Grand Avenue--Fifth Avenue to Sixth Avenue.

Grand Avenue, on the north side, from Fifth Avenue to a point 30 feet west thereof, no parking anytime.

Grand Avenue, on the north side, from <u>a point 75 feet west of</u> Fifth Avenue to a point <u>150-55</u> feet west thereof, passenger loading zone, <u>10 minute limit</u>.

Grand Avenue, on the north side, from Fifth Avenue to a point 150 feet west thereof, no parking 7:00 a.m. to 9:00 a.m.

Grand Avenue, on the north side, from Fifth Avenue to a point 150 feet-west thereof, no parking 4:00 p.m. to 6:00 p.m.


Grand Avenue, on the north side, from a point $150 \ 130$ feet west of Fifth Avenue to Sixth Avenue, no parking any time.

Grand Avenue, on the north side, from Sixth Street to a point 115 feet east thereof, no parking any time.

Sec. 114-3914. Grand Avenue--Fifth Avenue to Sixth Avenue.

Grand Avenue, on the north side, from a point 30 feet west of Fifth Avenue to a point 45 feet west thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

Grand Avenue, on the north side, parking meter G-501, two-hour meter, 8:00 a.m. to 6:00 p.m., is designated a handicapped parking space and is subject to the same prohibition as is found in section 114-616(a) of this chapter.





B. Traffic and Transportation received a request for a loading zone from a business owner at 15th Street and Walnut Street. Staff reviewed this request and determined that a loading zone at the requested location on the north side of Walnut Street east of 15th Street is feasible. As part of that review, staff also reviewed the existing parking restrictions on Walnut Street between 13th Street and 15th Street to determine if the code matched current field conditions. The following ordinance changes will place the requested loading zone into effect and implement code changes necessary to match existing field conditions.

Sec. 114-3744. Walnut Street--Thirteenth Street to Fifteenth Street.

Walnut Street, on the north side, from a point $\frac{170}{140}$ feet west of Thirteenth Street to a point 40 45 feet west thereof, commercial loading zone.

Walnut Street, on the north side, from a point 185 feet west of Thirteenth Street to a point 20 feet west thereof, no parking anytime.

Walnut Street, on the north side, from a point $60 \underline{45}$ feet west of Thirteenth Street to a point 25 feet west thereof, commercial loading zone.

Walnut Street, on the south side, from Thirteenth Street to a point $\frac{15}{20}$ feet west thereof, no parking any time.

Walnut Street, on the south side, from a point 250 feet west of Thirteenth Street to a point 35 feet west thereof, no parking anytime.

Walnut Street, on the south side, from a point $\frac{295}{285}$ feet west of Thirteenth Street to a point 35 feet west thereof, commercial loading zone.

Walnut Street, on the south side, from Fourteenth Street to a point 20 feet east thereof, no parking any time.

Walnut Street, on the south side, from Fourteenth Street to a point 10 feet west thereof, no parking anytime.

Walnut Street, on the south side, from a point $\frac{175}{180}$ feet west of Fourteenth Street to a point 45 feet west thereof, commercial loading zone.

Walnut Street, on the south side, from Fifteenth Street to a point $\frac{30}{20}$ feet east thereof, no parking any time.

Walnut Street, on the north side, from Fourteenth Street to a point $\frac{20}{55}$ feet west thereof, no parking any time.

Walnut Street, on the north side, from a point $\frac{56}{55}$ feet west of Fourteenth Street, to a point $\frac{34}{35}$ feet west thereof, commercial loading zone.

Walnut Street, on the north side, from a point $230 \ \underline{190}$ feet west of Fourteenth Street to a point 40 feet west thereof, commercial loading zone.

Walnut Street, on the north side, from a point 45 feet east of Fifteenth Street to a point 50 feet east thereof, commercial loading zone.

Walnut Street, on the north side, from Fifteenth Street to a point 85 20 feet east thereof, no parking any time.

Sec. 114-4040. Walnut Street--Thirteenth Street to Fifteenth Street.

Walnut Street, on the south side, from <u>a point 20 feet west of</u> Thirteenth Street to a point 295 230 feet west thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

Walnut Street, on the south side, from 300 320 feet west of Thirteenth Street to <u>a point 20 feet</u> east of Fourteenth Street, two-hour meters, 8:00 a.m. to 6:00 p.m.

Walnut Street, on the south side, from a point 10 feet west of Fourteenth Street to a point 175 170 feet west thereof, ten-hour meters, 8:00 a.m. to 6:00 p.m.

Walnut Street, on the south side, from a point $\frac{220}{225}$ feet west of Fourteenth Street to a point $\frac{30}{20}$ feet east of Fifteenth Street, ten-hour meters, 8:00 a.m. to 6:00 p.m.

Walnut Street, on the north side, from Thirteenth Street to a point $60 \underline{45}$ feet west thereof, fourhour meters, 8:00 a.m. to 6:00 p.m.


Walnut Street, on the north side, from a point 95 70 feet west of Thirteenth Street to a point 75 70 feet west thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

Walnut Street, on the north side, from a point 210 205 feet west of Thirteenth Street to Fourteenth Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

Walnut Street, on the north side, from a point 90 feet west of Fourteenth Street to a point 210 100 feet west thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

Walnut Street, on the north side, from a point $\frac{270}{230}$ feet west of Fourteenth Street to a point $\frac{85}{95}$ feet east of Fifteenth Street, four-hour meters, 8:00 a.m. to 6:00 p.m.

Walnut Street, on the north side, from a point 25 feet east of Fifteenth Street to a point 20 feet east thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.




C. The following code addition is necessary to implement a parking restriction on the south side of the recently constructed Bill Reichardt Way between SE 22nd Street and the new parking lot for the Cownie Baseball Complex.

Sec. 114-3017.3. Bill Reichardt Way-Southeast Twenty-Second Street to dead end west.

Bill Reichardt Way, on the south side, from Southeast Twenty-Second Street west to the dead end, no parking any time.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by

Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by adding

and enacting new Section 114-3017.3, and by amending Sections 114-3248, 114-3744, 114-3914 and

114-4040, relating to traffic and vehicle regulations, as follows:

Sec. 114-3017.3. Bill Reichardt Way-Southeast Twenty-Second Street to dead end west.

Bill Reichardt Way, on the south side, from Southeast Twenty-Second Street west to the dead end, no parking any time.

Sec. 114-3248. Grand Avenue--Fifth Avenue to Sixth Avenue.

Grand Avenue, on the north side, from Fifth Avenue to a point 30 feet west thereof, no parking any time.

Grand Avenue, on the north side, from <u>a point 75 feet west of</u> Fifth Avenue to a point <u>150 55</u> feet west thereof, passenger loading zone, <u>10-minute limit</u>.

Grand Avenue, on the south side, parking meter G-520, two-hour meter, 8:00 a.m. to 6:00 p.m., is designated a handicapped parking space and is subject to the same prohibition as is found in subsection 114-616(a) of this chapter.

<u>Grand Avenue, on the north side, from a point 30 feet west of Fifth Avenue to a point 45 feet</u> west thereof, two-hour meters, 8:00 a.m. to 6:00 p.m.

Walnut Street, on the south side, from 300_{320} feet west of Thirteenth Street to <u>a point 20</u> feet east of Fourteenth Street, two-hour meters, 8:00 a.m. to 6:00 p.m.

Walnut Street, on the south side, from <u>a point 10 feet west of</u> Fourteenth Street to a point <u>175</u> <u>170</u> feet west thereof, ten-hour meters, 8:00 a.m. to 6:00 p.m.

Walnut Street, on the south side, from a point-22025 feet west of Fourteenth Street to a point-3020 feet east of Fifteenth Street, ten-hour meters, 8:00 a.m. to 6:00 p.m.

Walnut Street, on the north side, from Thirteenth Street to a point-6045 feet west thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

Walnut Street, on the north side, from a point $\underline{95}$ <u>70</u> feet west of Thirteenth Street to a point $\underline{75}$ <u>70</u> feet west thereof, four-hour meters, 8:00 a.m. to 6:00 p.m.

Walnut Street, on the north side, from a point-<u>210</u> <u>205</u> feet west of Thirteenth Street to Fourteenth Street, four-hour meters, 8:00 a.m. to 6:00 p.m.
