## RESOLUTION APPROVING SUPPORT FOR AN APPLICATION BY ELECTRO MANAGEMENT CORP., AND ELECTRICAL POWER PRODUCTS, INC., TO THE IOWA ECONOMIC DEVELOPMENT AUTHORITY FOR FINANCIAL ASSISTANCE UNDER THE HIGH QUALITY JOBS PROGRAM

WHEREAS, Electro Management Corp. and Electrical Power Products, Inc. (hereinafter "EP2") have proposed to initiate an economic development project that will provide for a relocation and expansion of a business retaining a minimum of 200 jobs within the City of Des Moines; and,

WHEREAS, EP2 plans to submit an application for financial assistance for the proposed economic development project to the Iowa Economic Development Authority (IEDA) under the High Quality Jobs (HQJ) program and is seeking the City's support in requesting assistance from the IEDA; and,

WHEREAS, the HQJ program requires that any State financial assistance award be supplemented by a local community match up to 20% of the State award; and,

WHEREAS, the IEDA staff anticipates that EP2 may be eligible for up to \$414,103 in State assistance under the HQJ program, subject to the receipt and review of a full application and meeting all program requirements, thereby requiring a local community match of up to \$82,821 by the City; and,

WHEREAS, by separate resolution on this date the City Council has approved an Urban Renewal Development Agreement with EP2 which provides for the payment of an Economic Development Grant in an amount that exceeds the required local community match under the HQJ program.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, as follows:

- 1. The City of Des Moines hereby declares its support for the proposed project by Electro Management Corp. and Electrical Power Products, Inc., to relocate and expand their industrial facility at SW 42nd Street and Army Post Road, and for their application to the Iowa Economic Development Authority, for State assistance for the project under the High Quality Jobs program.
- 2. The Mayor hereby authorized and directed to sign the application on behalf of the City of Des Moines as an indication of the City's support for the project.
