## RESOLUTION RELEASING SUBDIVISION IMPROVEMENT BOND FOR RIVERPOINT PLAT NO. 4

WHEREAS, on May 23, 2005, by Roll Call No. 05-1253, the City Council approved the subdivision plat entitled Riverpoint Plat No. 4 for land located east of SW 7<sup>th</sup> Street and south of Murphy Street, to be developed by Hubbell Realty Company, represented by Rick Tollakson, President; and,

WHEREAS, by said Roll Call, the City Council further authorized the approval and acceptance of Subdivision Bond number IAC 45740 from Merchant's Bonding Company in the amount of \$1,654 as security for the estimated cost of sidewalk improvements; and,
