**SETTING DATE OF PUBLIC HEARING FOR APPROVAL OF THE  
2015 U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT  
CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT (CAPER)  
(3-21-16)**

**WHEREAS**, provisions under 24 CFR 91.520 regarding reporting on the implementation and management of the Consolidated Plan for HUD grant programs require the City to submit a Consolidated Annual Performance and Evaluation Report (CAPER) for the 2015 Program Year to the United States Department of Housing and Urban Development (HUD) no later than 90 days after completion of the 2015 Consolidated Plan Program Year; and

**WHEREAS**, the City Council must conduct a public hearing to review the 2015 HUD Consolidated Plan Program Year performance and receive citizen comments regarding the CAPER for the 2015 Consolidated Plan Program Year, and provide notice of the hearing to be published at least fifteen and no more than twenty days before it is held; and


**WHEREAS**, a copy of the proposed CAPER for the 2015 Program Year shall be made available for public review at the City Clerk's Office and at all library branches in order to provide citizens with the opportunity to participate in the hearing.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, that the public hearing to receive citizen views and comments on, and to consider approval of, the CAPER for the 2015 Consolidated Plan Program shall be held during the regular City Council meeting on March 21, 2016, at 5:00 p.m. in the Council Chambers in City Hall.

**BE IT FURTHER RESOLVED**, that the City Clerk is authorized and directed to publish notice of public hearing in the attached form in the Des Moines Register not less than fifteen (15) and no more than twenty (20) days prior to the date set for said hearing.

**NOTICE OF PUBLIC HEARING REGARDING THE 2015 U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT CONSOLIDATED ANNUAL PERFORMANCE AND EVALUATION REPORT (CAPER)**

TO ALL INTERESTED AGENCIES, GROUPS AND PERSONS

The City of Des Moines, proposes to submit a Consolidated Annual Performance and Evaluation Report (CAPER) for the 2015 program year to the U.S. Department of Housing and Urban Development on or about March 28, 2016.

The CAPER report documents the performance of the City of Des Moines' 2015 HUD Consolidated Plan, which includes Community Development Block Grant (CDBG), Home Investment Partnership (HOME) and Emergency Solutions Grant (ESG) funding and is available for public examination and copying upon request in the City Clerk's Office, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa between 8:00 a.m. and 5:00 p.m., Monday through Friday. The report is also available for public review at branches of the Des Moines Public Library: Central Library, 1000 Grand Avenue; Franklin Avenue Library, 5000 Franklin Ave.; Forest Avenue Library, 1326 Forest Ave.; North Side Library, 3516 Fifth Ave.; South Side Library, 1111 Porter Ave.; East Side Library, 2559 Hubbell Ave., during open hours.

The City Council of the City of Des Moines has determined that a Public Hearing should be held on March 21, 2016, at 5:00 p.m. in the Council Chambers, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa for the purpose of obtaining citizen views regarding the performance of the City of Des Moines as documented in the 2015 HUD CAPER report.

All persons wishing to comment on the 2015 CAPER report may state their views at this hearing or submit written comments, which will be attached as an addendum to the CAPER for consideration by HUD. Such written comments should be received at the Office of the City Clerk, City Hall, 400 Robert D. Ray Drive, Des Moines, Iowa 50309, before 12:00 noon on March 18, 2016.

Hearing impaired persons may request an interpreter by calling the City's TTY at 283-4081. Disabled persons attending the hearing should access City Hall through the West door and take the elevator at the North end of the building to the Council Chambers on the second floor.
