AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-671, 114-671.1, 114-671.1.1 and 114-3572, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-671, 114-671.1, 114-671.1.1 and 114-3572, relating to traffic and vehicle regulations, as follows:

**Sec. 114-671. ~~Repealed by Ord. No. 15,---~~ ~~East Fifth Street and East Grand Avenue Municipal Parking Lot.~~**

- (a) ~~The city engineer is hereby authorized and directed to install parking meters in the following described municipally owned parking lot:  
A tract of land bounded on the west by the east line of East Fifth Street; on the north by the south line of East Grand Avenue; on the south by the north line of the east and west alley lying between East Locust Street and East Grand Avenue; and on the east by a straight line one hundred forty (140) feet east of and parallel to the east line of East Fifth Street; in the City of Des Moines, Iowa, for the purpose of, and in such numbers, and at such places as may be necessary to the regulation, control and inspection of the parking of vehicles therein, subject to division 6 of this article, regulating parking meters.~~
- (b) ~~When installed, such parking meters shall be in operation between the hours of 8:00 a.m. and 6:00 p.m., Mondays through Fridays. Effective January 1, 2006 these parking meters shall conform to the parking meter rates listed in Parking Meter District III, as is found in section 114-643 of this code.~~
- (e) ~~The following rate shall be charged for reserved monthly parking 6:00 a.m. until 6:00 p.m., Mondays through Fridays.~~

- (a) ~~The city engineer is hereby authorized to install parking meters in the following described municipally owned parking lot: W. 20 Ft of Lot 4 and all of Lot 5, Block 9, East Fort Des Moines; in the City of Des Moines, Iowa for the purpose of, and in such numbers, and at~~

such places as may be necessary to the regulation, control and inspection of the parking of vehicles therein, subject to division 6 of this article, regulating parking meters.

- (b) — When installed, such parking meters shall be in operation between the hours of 8:00 a.m. and 6:00 p.m., Monday through Friday. Effective January 1, 2006 these parking meters shall conform to the parking meter rates listed Parking Meter District III, as is found in section 114-643 of this code.
- (c) — The following rate shall be charged for reserved monthly parking 8:00 a.m. until 6:00 p.m., Monday through Friday.

- (a) — The city engineer is hereby authorized to install parking meters in the following described municipally-owned parking lot: E 47.5 F LOT 6 BLK 9 EAST FORT DES MOINES; in the City of Des Moines, Iowa for the purpose of, and in such numbers, and at such places as may be necessary to the regulation, control and inspection of the parking of vehicles therein, subject to division 6 of this article, regulating parking meters.
- (b) — When installed, such parking meters shall be in operation between the hours of 8:00 a.m. and 6:00 p.m., Monday through Friday. Effective January 1, 2006 these parking meters shall conform to the parking meter rates listed Parking Meter District III, as is found in section 114-643 of this code.
- (c) — The following rate shall be charged for reserved monthly parking 8:00 a.m. until 6:00 p.m., Monday through Friday.

**Sec. 114-3572. Pleasant Drive--Fifty-sixth Street to Sixty-third Street.**

Pleasant Drive, on the north side, from Fifty-sixth Street to a point 50 feet west thereof, no parking any time.

Pleasant Drive, on the south side, from Fifty-sixth Street to Sixty-third Street, no parking any time.

Pleasant Drive, on the north side, from Cummins Parkway to a point ~~210~~ 240 feet east thereof, no parking any time.

Pleasant Drive, on the north side, from a point 235 feet west of Sixty-first Street to Sixty-second Street, no parking any time.

Pleasant Drive, on the north side, from Sixty-third Street to a point 75 feet east thereof, no parking any time.

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
