WHEREAS, on June 8, 2015 under Roll Call No. 15-0900, the City Council approved a private construction contract in the amount of \$9,539.00, between Iowa Signal Inc., Wayne Lesley, President, 3711 SE Capitol Circle, Grimes, IA, 50111 - as Contractor, and Grand View University, Kent Henning, President, 1200 Grandview Avenue, Des Moines, IA, 50316 - as Owner, for construction of Signalization Improvements described as including modifications of existing mid-block traffic signal on N.E. 14th Street south of Boyd Street including the adding of a southbound three-section vehicle signal indication on a pedestal pole in the median south of the paved sidwalk area, all in accordance with the contract documents including Plan File Nos. 569-051/052, and granted permission to the parties of said contract to construct these improvements in accordance with the contract documents and subject to the inspection and approval of the Des Moines City Engineer.




