SETTING DATE OF PUBLIC HEARING FOR APPROVAL OF THE 2016 U.S. DEPARTMENT OF HOUSING AND URBAN DEVELOPMENT (HUD) ACTION PLAN FOR THE 2015-2019 CONSOLIDATED PLAN (4-11-16)

WHEREAS, provisions under Code of Federal Regulations (CF) Chapter 24, Section 91.220 regarding Annual Action Plans for the Consolidated Plan for HUD grant programs require the City to submit an annual action plan for the 2016 Program Year to the United States Department of Housing and Urban Development (HUD) no later than 45 days prior to start of the 2016 Consolidated Plan Program Year, as amended by the HUD CPD Notice 16-0 dated January 28, 2016; and

WHEREAS, the City Council must conduct a public hearing to review the 2016 HUD Consolidated Plan Program Year activities and receive citizen comments regarding the Action Plan for the 2016 Consolidated Plan Program Year, and provide notice of the hearing to be published at least thirty days before it is held; and

WHEREAS, a copy of the proposed Action Plan for the 2016 Program Year shall be made available for public review at the City Clerk's Office and at all Des Moines Public Library branches in order to provide citizens with the opportunity to participate in the hearing.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that the public hearing to receive citizen views and comments on, and to consider approval of, the Action Plan for the 2016 Consolidated Plan Program Year shall be held during the regular City Council meeting on April 11, 2016, at 5:00 p.m. in the Council Chambers in City Hall.

BE IT FURTHER RESOLVED, that the City Clerk is authorized and directed to publish notice of public hearing in the attached form in the Des Moines Register not less than thirty (30) days prior to the date set for said hearing.
