## RESOLUTION APPROVING ISSUANCE OF CERTIFICATE OF COMPLETION TO SHERMAN GRAY'S LANDING HOTEL DEVELOPMENT LLC

(Holiday Inn Express Hotel at 333 SW 11th)

WHEREAS, on September 22, 2014, by Roll Call No. 14-1521, the City Council approved a Parcel Development Agreement with Sherman Gray's Landing Hotel Development, LLC (the "Developer"), represented by George Sherman, President, whereby the Developer agreed to improve the property and surrounding land at 333 SW 11<sup>th</sup> Street, by constructing a 4-story, 102 room Holiday Inn Express Hotel, including all necessary or required site improvements (collectively the "Improvements"), at a total estimated project cost of over \$12.5 million, all to be in conformance with the approved Conceptual Development Plan; and,

WHEREAS, the Improvements to the property at 333 SW 11<sup>th</sup> Street have been completed in substantial compliance with the Development Agreement and the approved Conceptual Development Plan; and,

**WHEREAS**, the Developer has requested the City issue a Certificate of Completion as evidence of Developer's satisfaction of its construction obligation under the Development Agreement.

**NOW THEREFORE, BE IT RESOLVED,** by the City Council of the City of Des Moines, Iowa, as follows:

1. The City Council hereby finds and acknowledges that Sherman Gray's Landing Hotel Development LLC has satisfied its obligation to complete the construction of the Improvements at 333 SW 11<sup>th</sup> Street, more specifically described as follows:

Parcel "A" of part of Lots 1 and 3, in Terminal Place, an Official Plat; and Parcel "A" of part of Lot 5, Factory Addition Plat 3, an Official Plat, in the City of Des Moines, Polk County, Iowa, as shown by the Plat of Survey recorded in Book 15041 at Page 670, in the office of the Recorder of Polk County, Iowa.

in substantial compliance with the Development Agreement and the approved Conceptual Plan. This resolution shall serve as the Certificate of Completion to be issued by the City pursuant to Section 2.5 of the Development Agreement.

2. The City Clerk is hereby directed to cause a certified copy of this resolution and roll call to be delivered to the City's Office of Economic Development, and the Office of Economic Development is directed to cause the certified copy to be delivered to the Developer for recording.
