AGENDA HEADING:

Amending Chapter 114 of the Municipal Code as follows:

- A. Extending no parking area on Pleasant Drive east of Cummins Parkway.
- B. Elimination of three (3) surface parking lots in the East Village from the Municipal Code due to the sale of property for development.

SYNOPSIS:

Recommend approval of the staff recommendations, including first reading of the ordinance regarding the traffic regulation changes.

FISCAL IMPACT:

Amount: Minor costs for signing modifications.

Funding Source: FY2017 Recommended Operating Budget, page 78 Engineering Department Traffic and Transportation—Sign Installation and Maintenance, EG062080.

ADDITIONAL INFORMATION:

- A. The property owner of 5828 Pleasant Drive requested that the parking restriction on the north side of Pleasant Drive east of Cummins Parkway be extended east due to difficulty in backing into Pleasant Drive from the property's driveway.

Pleasant Drive is a 25-foot-wide local street in this area and includes horizontal curves just east of Cummins Parkway. Pleasant Drive has a posted speed limit of 25 mph. Parking is currently restricted along the south side of Pleasant Drive throughout the area and is restricted on the north side along the horizontal curves. There is an approximately 30-foot area where parking is currently allowed on the north side of the street just west of the driveway to 5821 Pleasant Drive. This is enough for one (1) vehicle to park.

The property owner of 5828 Pleasant Drive has provided a petition with all four (4) of the impacted homeowners in support of the change to extend the No Parking Any Time restriction on the north side another 30 feet east.

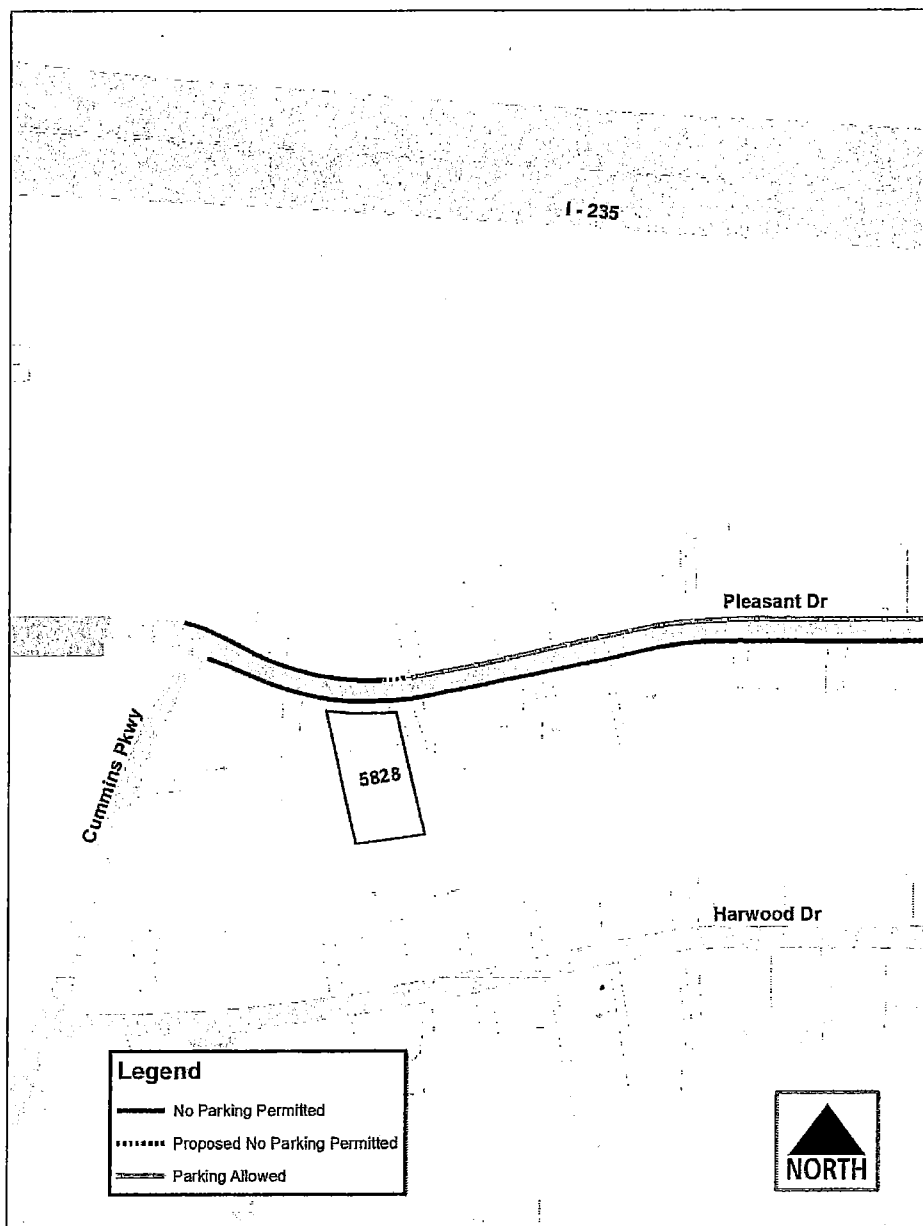
Staff recommended that the existing parking restriction be extended 30 feet east along the north

side of Pleasant Drive from the current limits. This No Parking Any Time restriction will now be from Cummins Parkway to a point 240 feet east thereof.

At their January 19, 2016 meeting, the Traffic Safety Committee unanimously concurred with staff recommendation. The following revision to the Municipal Code will place this parking restriction into effect.

Sec. 114-3572. Pleasant Drive—Fifty-sixth Street to Sixty-third Street.

Pleasant Drive, on the north side, from Cummins Parkway to a point ~~210~~ 240 feet east thereof, no parking any time.



B. Recent purchases of City-owned parking lots related to development has eliminated these three (3) surface parking lots in the East Village. The following revisions will remove these sections from the Municipal Code.

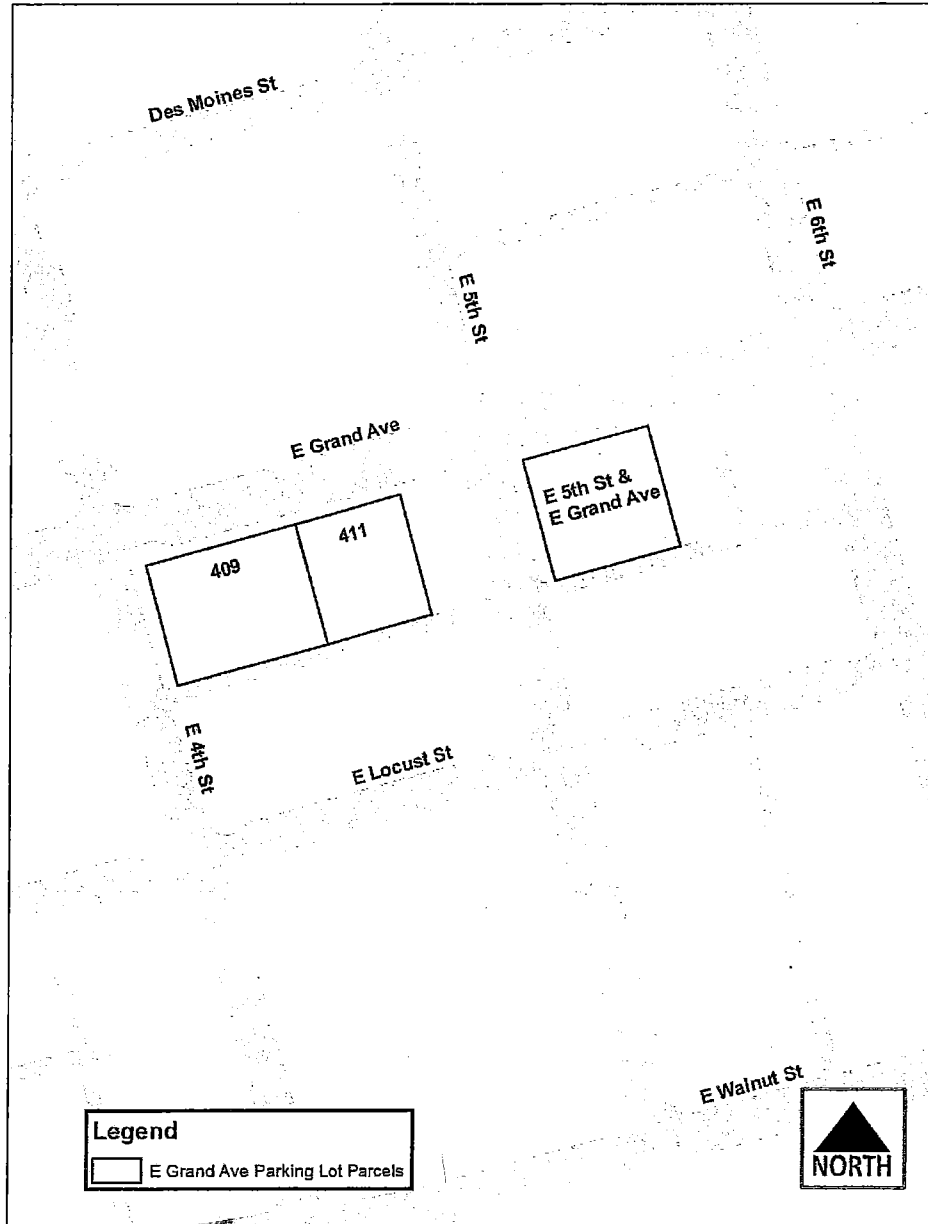

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-671, 114-671.1, 114-671.1.1 and 114-3572, relating to traffic and vehicle regulations, as follows:

Pleasant Drive, on the north side, from a point 235 feet west of Sixty-first Street to Sixty-second Street, no parking any time.

Pleasant Drive, on the north side, from Sixty-third Street to a point 75 feet east thereof, no parking any time.
