## REVIEW OF CITY HALL IMPROVEMENTS PROJECT IN ACCORDANCE WITH THE-TAXPAYER QUALITY ASSURANCE POLICY

WHEREAS, Iowa Code 26.9 requires that contracts for public improvements be awarded to the "lowest responsive, responsible bidder" and Iowa court decisions allow public entities to consider factors other than price in determining who is the lowest responsible bidder; and

WHEREAS, the Des Moines City Council in recognition of this and that Vertical Infrastructure Projects are designed for human occupancy and construction of these projects can be complex and difficult, adopted a policy entitled "City of Des Moines Taxpayer Quality Assurance Policy" on September 8, 2014 by Roll Call No. 14-1417, for evaluating the necessity for additional information from bidders to assist in determining the lowest responsible bidder on Vertical Infrastructure Projects; and

WHEREAS, the Des Moines City Council revised the "City of Des Moines Taxpayer Quality Assurance Policy" on March 7, 2016 by Roll Call No. 16-0416, to require the Policy to apply to Vertical Infrastructure Projects that have or will require a certificate of occupancy, at one Council meeting prior to consideration of the Ordering of Construction for a qualifying Vertical Infrastructure project Council will consider and determine the process and whether the Policy will apply, modify subcontractor requirement to allow notification if a subcontractor is under current investigation, and the questionnaire will be submitted with the bid rather than two weeks prior to the deadline for accepting bids; and

WHEREAS, the City Hall Improvement project is a Vertical Infrastructure Project as defined under the Taxpayer Quality Assurance Policy; and

WHEREAS, the City Engineering Department, in accordance with the Taxpayer Quality Assurance Policy, is submitting the City Hall Improvement Project to Council for Council review; and

WHEREAS, the City Council, in accordance with the Policy, shall determine whether the City Hall Improvement Project, as further described in the Council Communication attached to this Roll Call, is of such magnitude, scope or complexity that Council determines it necessary to request bidders to complete the General Contractor Quality Assurance Questionnaire and whether to include the Subcontractor Quality Assurance Bid Requirements on the Project.
