Re: Report to Council

Pursuant to the authority and direction of Council authorizing the City Attorney to settle claims, lawsuits and workers compensation actions for a total sum not to exceed \$5,000, I submit to Council the following summary report of settlements made:

SELENE FINANCIAL \$1,875.00 for sewer backup on 10/24/15 at 220 Leland Avenue, owned by SRMOF II 2012-1 Trust, which was caused by a blocked City main.

TIMOTHY KINNAN \$30.00 for a damaged mailbox at 5714 South Union Street, which was struck by a City snow plow on December 28, 2015.

DARLENE CALDERON \$2,458.75 for property damage to legally parked vehicle by a City snow plow at 2757 Boston Avenue on December 30, 2015.

GARY SONDERLEITER \$322.80 for damage to Claimant's windshield on December 29, 2015 when a City snow plow threw a piece of rock salt into the windshield, cracking it.

TIMOTHY & DIANNE JORDAN \$122.27 for property damage at 127 Tonawanda Drive on December 28, 2015, when City snow plow went over curb into Claimant's yard and damaged electric fence.
