ACCEPTANCE OF REAL ESTATE DOCUMENTS FROM DOROTHY F. NEUMANN, AS TRUSTEE OF THE DOROTHY F. NEUMANN 2003 TRUST U/A DATED JULY 15, 2003, FOR DONATION OF A PORTION OF THE PROPERTY LOCATED AT 4101 JOHN LYNDE ROAD

WHEREAS, Dorothy F. Neumann, Trustee of the Dorothy F. Neumann 2003 Trust U/A dated July 15, 2003, is the owner of property located at 4101 John Lynde Road, and has offered to donate the portion of the property that is encumbered with an existing sanitary sewer to the City of Des Moines, Iowa ("City"); and

WHEREAS, the City does not currently have an easement to access the property for maintenance and repair of the existing sanitary sewer and the City's Real Estate Division recommends accepting donation of the property.

That the Real Estate Division of the Engineering Department is directed to obtain the Legal Department's review and approval of all closing documents prior to closing.

That the City Clerk is hereby authorized and directed to endorse upon the Offer to Purchase, Purchaser's Affidavit and the Warranty Deed the approval and acceptance of this Council; the Mayor is authorized and directed to sign all necessary real estate documents associated with this acquisition; and the City Clerk is further authorized and directed to deliver the aforementioned documents to the Real Estate Division Manager, who shall proceed to closing in accordance with standard real estate practices.



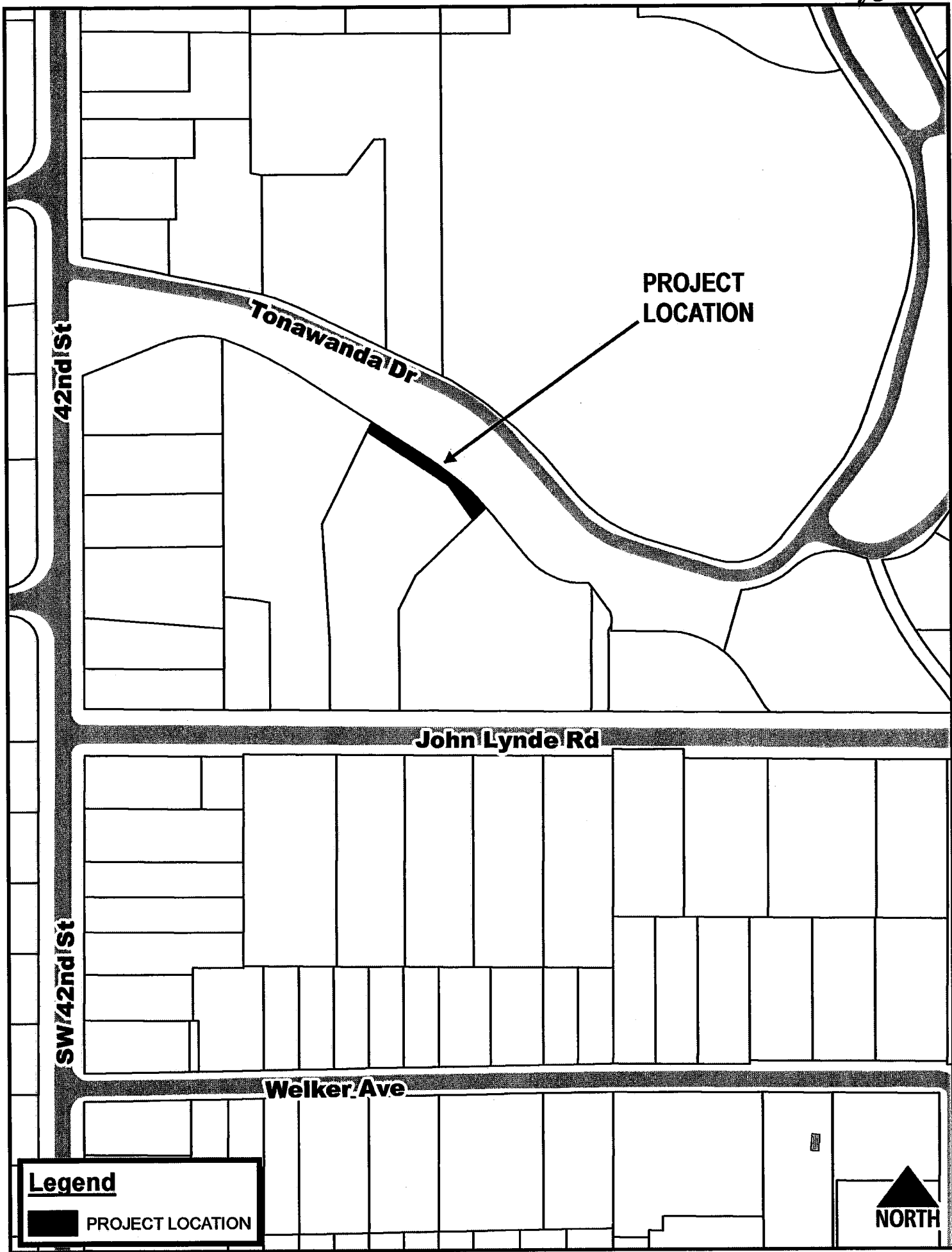
