## **APPROVING AND AUTHORIZING THE EXECUTION OF IOWA INTERSTATE RAILROAD, LTD. GRADE CROSSING SURFACE REPAIR PROGRAM AGREEMENTS FOR** 2<sup>nd</sup> AVENUE AND 3<sup>rd</sup> STREET

WHEREAS, the City of Des Moines and Iowa Interstate Railroad, Ltd. submitted requests for Iowa Grade Crossing Repair Program Funds for 2<sup>nd</sup> Avenue (FRA No. 603717C) and 3<sup>rd</sup> Street (FRA No. 603718J); and

WHEREAS, the Iowa Department of Transportation, Office of Rail Transportation, has approved use of these funds for repairs and improvements on 2<sup>nd</sup> Avenue (Federal Aid 603717C) and 3<sup>rd</sup> Street (FRA No. 603718J). The total estimate of the project is \$198,500 of which the City's participation is 20%, or \$35,700.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the agreements between the City of Des Moines and Iowa Interstate Railroad, Ltd. for Grade Crossing Repair Program for 2<sup>nd</sup> Avenue (Federal Aid 603717C) and 3<sup>rd</sup> Street (FRA No. 603718J), be and is hereby approved subject to approval by Iowa Interstate Railroad, Ltd., and the Mayor is authorized and directed to sign such agreements, and the City Clerk to attest to the Mayor's signature, and return three original copies to the Engineering Department for transmittal to the Iowa Department of Transportation.

IT IS FURTHER RESOLVED that the Finance Director is hereby authorized to make payment to Iowa Interstate Railroad, Ltd. for said Grade Crossing Surface Repair Program upon receipt of an invoice from Iowa Interstate Railroad, Ltd., and approval by the City Engineer.
