AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2845 and 114-3341.02, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2845 and 114-3341.02, relating to traffic and vehicle regulations, as follows:

**Sec. 114-2845. East Twenty-seventh Street--Dean Avenue to East Aurora Avenue.**

East Twenty-seventh Street, on the east side, from Dean Avenue to East University Avenue, no parking any time.

East Twenty-seventh Street, on the east side, from a point 50 feet north of Capitol Avenue to a point 50 feet south of Capitol Avenue, no parking any time.

East Twenty-seventh Street, on the east side, from a point 50 feet north of East Grand Avenue to a point 50 feet south of East Grand Avenue, no parking any time.

East Twenty-seventh Street, on the east side, from East University Avenue to a point 50 feet north thereof, no parking any time.

East Twenty-seventh Street, on the west side, from East University Avenue to a point 75 feet north thereof, no parking any time.

East Twenty-seventh Street, on the east side, from Kinsey Avenue to a point 140 feet south thereof, no parking any time.

East Twenty-seventh Street, on the west side, from a point 75 feet south of East University Avenue to Guthrie Avenue, no parking any time.

East Twenty-seventh Street, on the east side, from Easton Boulevard to a point 125 feet north thereof, no parking any time.

East Twenty-seventh Street, on the east side, from Guthrie Avenue to a point 50 feet south thereof, no parking any time.

East Twenty-seventh Street, on ~~the west side~~ both sides, from Avenue Frederick M. Hubbell to Hull Avenue, ~~a point 50 feet north thereof~~, no parking any time.

~~East Twenty-seventh Street, on the east side, from Avenue Frederick M. Hubbell to Hull Avenue, no parking any time.~~

~~East Twenty-seventh Street, on the west side, from Hull Avenue to a point 75 feet south thereof, no parking any time.~~

East Twenty-seventh Street, on the east side, from East Douglas Avenue to East Aurora Avenue, no parking any time.

East Twenty-seventh Street, on the west side, from East Madison Avenue to a point 60 feet south thereof, no parking any time.

**Sec. 114-3341.02. Indianola Road--South Union Street to Thomas Beck Road.**

Indianola Road on the south side, from South Union Street to a point 100 feet east of Southwest First Street, no parking 7:00 a.m. to 6:00 p.m., Monday through Friday.

Indianola Road on the north side, from a point 100 feet east of Southwest First Street to a point 180 feet east of Southwest First Street, is designated a handicapped parking space and is subject to the same prohibition as is found in section 114-616(a) of this Code.

Indianola Road on the north side, from a point 180 feet east of Southwest First Street to ~~South Union Street~~ 210 feet east thereof, is designated a handicapped parking space on Saturday and Sunday and is subject to the same prohibition as is found in section 114-616(a) of this Code.


Indianola Road on both sides, from ~~a point 100 feet east of Southwest First Street to Thomas Beck Road~~ a point 100 feet west of Southwest First Street, no parking any time.

Indianola Road on both sides, from Thomas Beck Road to Southwest Ninth Street, no parking any time.

~~Indianola Road, on both sides, from Courtland Drive to Thomas Beck Road, no parking any time.~~

Section 2. This ordinance shall be in full force and effect from and after its passage and publication as provided by law.
