HOLD HEARING FOR CONVEYANCE OF A SANITARY SEWER EASEMENT ACROSS CITY-OWNED PROPERTY LOCATED AT THE SOUTHEAST CORNER OF 63RD STREET AND GRAND AVENUE TO THE CITY OF WEST DES MOINES, IOWA, FOR THE CITY OF WEST DES MOINES' GRAND AVENUE SIPHON REPLACEMENT PROJECT FOR \$1.00

WHEREAS, a permanent sanitary sewer easement and temporary construction easement has been requested by the City of West Des Moines, Iowa, across property owned by the City of Des Moines, Iowa, located at the southeast corner of Grand Avenue and 63rd Street, for the West Des Moines' Grand Avenue Siphon Replacement Project, which involves replacing an existing West Des Moines sanitary sewer; and
