RESOLUTION CONINUING DATE OF PUBLIC HEARING ON PETITION TO ESTABLISH THE SW 9TH CORRIDOR SELF-SUPPORTED MUNICIPAL IMPROVEMENT DISTRICT AND SETTING NEW HEARING DATE.

WHEREAS, a hearing date was previously set for May 23, 2016 in Roll Call No. 16-0670; a new hearing date needs to be set to provide additional notice as required by Iowa Code section 386.3(4).

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, as follows:

- 1. That the hearing previously set for May 23, 2016 is continued until June 13, 2016.
- 2. That the City Council consider the Petition to Establish the SW 9th Corridor Self-Supported Municipal Improvement District at a public hearing to be held on June 13, 2016, at 5:00 p.m., in the Council Chambers at which time the City Council will hear both those who oppose and those who favor the proposal.
- 3. That notice of said proposal shall also be given by certified mail not less than 15 days before the hearing to each property owner within the proposed district at the owner's address as shown by the records of the County Auditor, all as required by Iowa Code section 386.3(4).
