## **RESOLUTION RECEIVING AND FILING AMENDMENTS TO THE BYLAWS OF NEIGHBORHOOD DEVELOPMENT CORPORATION**

WHEREAS, Neighborhood Development Corporation ("NDC") is an Iowa non-profit corporation that is managed by a Board of Directors that contains some members appointed and subject to removal by the City Council, and that works with the City, Polk County, and other governmental units within Polk County to combat community deterioration through community redevelopment efforts designed to in assist in the creation of housing, small business, and employment opportunities in low- to moderate-income census tracts; and

WHEREAS, the Board of Directors of NDC seeks to amend the corporation Bylaws to allow the Executive Director or Director of Real Estate Development to execute deeds, mortgages, and contracts exceeding \$10,000 with attestation by a corporate officer, as summarized in the attached letter from Glenn Lyons, NDC's Executive Director, and the City Manager and City Community Development Department staff are in support of acceptance of the amendments.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa, that the attached letter from NDC setting forth the proposed amendments to the NDC Bylaws is hereby received and filed, and that the City has no objection to the proposed amendments to the Bylaws of NDC.

Mayor Cownie and Members of City Council:

Neighborhood Development Corporation respectfully requests approval of its Bylaws. On October 21, 2015, the NDC Board of Directors approved the requested NDC Bylaws change, which involves signing authority as described below.

Note: Proposed Changes shown in yellow shading

In Article IV, Section 1 'Written Instruments'

To remove the following:

'All deeds and mortgages made by the corporation and all other written contracts and agreement involving amounts in excess of Ten Thousand Dollars (\$10,000) to which the corporation is a party shall be executed in its name by the President or Executive Director and attested by the Secretary, Vice President or Treasurer. All other written contracts and agreements, which involved amounts of Ten Thousand Dollars (\$10,000) or less to which the Corporation is a party may be executed in its name by either the president of the Executive Director.'

• And to replace it with the following

'All deeds and mortgages made by the corporation and all other written contracts and agreement involving amounts in excess of Ten Thousand Dollars (\$10,000) to which the corporation is a party shall be executed in its name by the Executive Director or Director of Real Estate Development and attested by the President, Vice President, Secretary, or Treasurer. All other written contracts and agreements, which involved amounts of Ten Thousand Dollars (\$10,000) or less to which the Corporation is a party may be executed in its name by either the President of the Executive Director.
