RESOLUTION FIXING DATE FOR A MEETING ON THE PROPOSITION OF THE ISSUANCE OF NOT TO EXCEED \$33,500,000 GENERAL OBLIGATION REFUNDING BONDS, SERIES 2016B OF THE CITY OF DES MOINES, STATE OF IOWA (FOR ESSENTIAL CORPORATE PURPOSES), AND PROVIDING FOR PUBLICATION OF NOTICE THEREOF

WHEREAS, it is deemed necessary and advisable that the City of Des Moines, State of Iowa, should issue General Obligation Refunding Bonds, to the amount of not to exceed \$33,500,000, as authorized by Section 384.25, of the Code of Iowa, for the purpose of providing funds to pay costs of carrying out essential corporate purpose projects as hereinafter described; and

WHEREAS, before the Bonds may be issued, it is necessary to comply with the provisions of the Code, and to publish a notice of the proposal to issue such bonds and of the time and place of the meeting at which the Council proposes to take action for the issuance of the Bonds and to receive oral and/or written objections from any resident or property owner of the City to such action.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF CITY OF DES MOINES, STATE OF IOWA:

That this Council meet in the Council Chambers, Municipal Service Center, 1551 E. M. L. King Jr. Pkwy., Des Moines, Iowa, at 5:00 P.M., on the 25th day of July, 2016, for the purpose of taking action on the matter of the issuance of not to exceed \$33,500,000 General Obligation Refunding Bonds, Series 2016B, for essential corporate purposes, the proceeds of which bonds will be used to provide funds to pay the costs of refunding and refinancing General Obligation Bonds, Series 2009E (Taxable Build America Bonds), dated June 29, 2009 and General Obligation Bonds, Series 2010D, dated June 25, 2010.

To the extent any of the projects or activities described in this resolution may be reasonably construed to be included in more than one classification under Division III of Chapter 384 of the Code of Iowa, the Council hereby elects the "essential corporate purpose" classification and procedure with respect to each such project or activity, pursuant to Section 384.28 of the Code of Iowa.

That the Clerk is hereby directed to cause at least one publication to be made of a notice of the meeting, in a legal newspaper, printed wholly in the English language, published at least once weekly, and having general circulation in the City. The publication to be not less than four
