PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON MUNICIPAL BUILDINGS REROOFING - CONTRACT 2; RECEIVE AND FILE BIDS; AND DESIGNATION OF LOWEST RESPONSIVE, RESPONSIBLE BIDDER AS BRAZOS URETHANE, INC., HOWARD W. SCOGGINS, III, PRESIDENT, \$183,457.00

WHEREAS, on June 27, 2016, under Roll Call No. 16-1017, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

Municipal Buildings Reroofing - Contract 2, 10-2016-008

The improvement includes the repair of the existing roofing materials and installation of a sprayed polyurethane foam roof on three municipal buildings; all work in accordance with the contract documents including Plan File Nos. 574-008/014, located at Public Works Sign Shop - 216 S.E. 5th Street, Armory Building - 602 Robert D. Ray Drive, and Glendale Cemetery Abbey - 4909 University Avenue, in Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement be closed; and that said plans, specifications, form of contract documents, and Engineer's estimate of construction cost are hereby approved as the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement.

which were received and opened at a public meeting presided over by the Engineer in the Shijiazhuang Room, 2nd Floor, City Administration Building, 400 E. Court Avenue, Des Moines, Iowa at 11:00 a.m. on July 12, 2016. Said bids and the attached tabulation of bids for said improvement be and are hereby received and filed.

BE IT FURTHER RESOLVED: That the Des Moines City Engineer, as the Engineer, has determined that the lowest responsive, responsible bid for the construction of said improvement was submitted by Brazos Urethane, Inc., Howard W. Scoggins, III, President, 1031 6th Street North, Texas City, TX, 77590 in the amount of \$183,457.00, and said bid be and the same is hereby accepted.



BE IT FURTHER RESOLVED: That the City Council hereby authorizes the necessary road closures for the Project.
