## RESOLUTION IN SUPPORT OF A WORKFORCE HOUSING TAX CREDIT (WHTC) BENEFIT APPLICATION TO BE SUBMITTED TO THE IOWA ECONOMIC DEVELOPMENT AUTHORITY (IEDA) BY NEIGHBORHOOD DEVELOPMENT CORPORATION, FOR A HOUSING PROJECT AT 3201 FOREST AVENUE

WHEREAS, the Neighborhood Development Corporation, represented by Abbey Gilroy, Director, has requested City support for its application to the Iowa Economic Development Authority ("IEDA") for state tax incentives under the Workforce Housing Tax Credit Program for an approximately \$7.6 million, 50 dwelling unit, 2 story multi-family project on property at 3201 Forest Avenue, to be known as "Forest Avenue Village"; and

WHEREAS, successful completion of the "Forest Avenue Village" project requires funding from a number of sources, including an award of Iowa Workforce Housing Tax Credit benefits in the estimated amount of \$968,398.00; and

WHEREAS, on April 11, 2016 by Roll Call Number 16-0611, the City Council approved a resolution of support submitted on behalf of JKLM Real Estate, LLC for a housing project at this location containing 48 dwelling units; and

WHEREAS, an updated resolution of support is required to reflect the updated number of dwelling units and new applicant on the revised project; and

WHEREAS, the application requirements for the Workforce Housing Tax Credit Program include a requirement for the submission of a resolution in support of the housing project by the community where the housing project will be located, which requirement is intended to be satisfied by the is roll call and resolution; and

WHEREAS, a further application requirement for the Workforce Housing Tax Credit Program is documentation of a local matching funds pledged for the project in an amount not less than \$1,000 per dwelling unit; and

WHEREAS, the "Forest Avenue Village" project is located within the proposed Forest Avenue Urban Renewal Area and TIF District, and provided that the project is completed as planned, the taxable value added to the property by completion of the project will qualify for a temporary tax rebate from property taxes (a/k/a TIF assistance), providing financial assistance of approximately \$731,319 based on the estimated annual property taxes.
