## **RESOLUTION APPROVING AMENDMENTS TO THE SCHEDULE OF FEES** FOR FEES IMPOSED BY CHAPTER 60, HOUSING CODE

WHEREAS, by Ordinance No. 15,495 passed August 8, 2016, the City Council adopted a new Chapter 60, Housing Code, to the Des Moines City Code; and,

WHEREAS, Ordinance No. 15,495, amended Chapter 60 regarding residential property maintenance code, public nuisance code and real estate contract sales inspection; and

WHEREAS, the purpose of the proposed amendment to the Schedule of Fees is to reflect the changes to the organization of Chapter 60 and the new section numbers assigned to the various provisions that reference the Schedule of Fees; and,

WHEREAS, further purpose of the proposed amendment to the Schedule of Fees is to add and clarify the fees for an appeal, appeal of denial of a renovation agreement, modification, and denial of use of an alternative material, method or equipment.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the adopted Schedule of Fees for the City of Des Moines is hereby amended by amendment of the fees imposed pursuant to Chapter 60 of the City Code to be as set forth in the accompanying schedule, effective August 26, 2016.
