## SET HEARING FOR CONVEYANCE OF RAIL EASEMENT IN SE AGRIMERGENT BUSINESS PARK TO DES MOINES COLD STORAGE, INC.

WHEREAS, on June 27, 2016, by Roll Call No. 16-1087, the City Council held a public hearing and approved the proposed purchase by Des Moines Cold Storage, Inc. and Crossroads Cold Storage, LLC (collectively "Developer") of City-owned property located at SE 43<sup>rd</sup> Street and Vandalia Road in the City's SE Agrimergent Business Park (also known as the SE AgriBusiness Park Urban Renewal Area), and approved an Urban Renewal Development Agreement with Developer, for relocation and expansion of the home office of Developer's multi-state business; and

WHEREAS, as part of the Development Agreement, the City agreed to undertake the property disposition process set forth in Iowa Code Section 364.7 for conveyance to Des Moines Cold Storage, Inc., and/or affiliated entity Crossroads Cold Storage, LLC, of an easement for rail spur usage over and across Cityowned property adjoining the parcel acquired by Developer; and

WHEREAS, the easement will be granted to Developer in exchange and as consideration for Developer's improvements in the SE Agrimergent Business Park, to provide access from an existing railroad track to Developer's property which is essential to Developer's business model and relocation to the Business Park; and

WHEREAS, there is no known current or future public need for the easement proposed to be granted and the City will not be inconvenienced by the conveyance of said property interest.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. The City Council of the City of Des Moines, Iowa, proposes to convey an easement for rail spur usage to Des Moines Cold Storage, Inc. and/or Crossroads Cold Storage, LLC, within City-owned property in the SE Agrimergent Business Park at SE 43<sup>rd</sup> Street and Vandalia Road, as legally described below
