RESOLUTION AMENDING CDBG PROJECT AGREEMENT WITH 6^{TH} AVENUE CORRIDOR, INC. FOR REDEVELOPMENT PROJECT IN THE 6^{TH} AVENUE CORRIDOR AREA

WHEREAS, the blighted and/or vacant structure locally known as 1714 6th Avenue (Urban Dreams) (herein "Property") has been determined to pose an impediment to the redevelopment of the 6th Avenue Corridor; and

WHEREAS, the redevelopment of the Property was identified as a top priority in the planning process for the 6th Avenue Corridor, and by the Neighborhood Development Division of the City's Community Development Department; and

WHEREAS, 6th Avenue Corridor, Inc. ("6AC") proposes to redevelop the Property, following acquisition and demolition of the existing structure(s), and to either complete the redevelopment project itself or, with City staff, select a suitable for-profit or non-profit developer to purchase the property from 6AC, subject to affordability covenants and with purchase proceeds returned to the City as project income, for development of a future affordable multi-family housing project; and

WHEREAS, the City of Des Moines has allocated \$318,650 of Community Development Block Grant (CDBG) funding for fiscal year 2015 for Neighborhood Revitalization Plan Implementation; and

WHEREAS, the City proposes to utilize up to \$200,000 of such CDBG funding to assist 6AC in the above-described project for redevelopment of the blighted property and for low-rent housing purposes, pursuant to the Neighborhood Revitalization Plan; and

WHEREAS, on July 11, 2016, by Roll Call No. 16-1130, the City Council approved a CDBG Project Agreement with the 6AC to provide funding for the project in the amount of \$150,000; and

WHEREAS, demolition and asbestos abatement bids for the project have since been received that have increased the overall project budget, and City staff and 6AC are proposing to increase the current funding amount for the project to \$200,000, and 6AC has further requested that the project completion deadlines be extended to allow property acquisition to occur no later than December 31, 2016, and demolition to occur no later than March 31, 2016, with final project deadline of December 31, 2017 remaining as originally approved; and

WHEREAS, 6AC's proposed project for redevelopment of the Property is set forth in an amendment to the CDBG Project Agreement between the City and 6AC, in substantially the form on file in the office of the City Clerk, and, due to the nature and amount of such amendment, the amendment is being presented to City Council for consideration and approval.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that:
