## RESOLUTION ESTABLISHING REVISED FAIR MARKET VALUE OF PROPERTY OWNED BY RSC PARTNERS, LLC AT 900 42ND STREET FOR THE 42ND STREET STREETSCAPE PROJECT

WHEREAS, on March 21, 2016, by Roll Call No. 16-0449, the City Council of the City of Des Moines, Iowa authorized the acquisition, by gift, negotiation, or eminent domain, of the right-of-way and easements required for the 42<sup>nd</sup> Street Streetscape Project; and
