RESOLUTION APPROVING CDBG PROJECT AGREEMENT WITH 6^{TH} AVENUE CORRIDOR, INC. FOR REDEVELOPMENT PROJECT IN THE 6^{TH} AVENUE CORRIDOR AREA

WHEREAS, the blighted and/or vacant structure locally known as 1601-1605 6th Avenue (Anchulee Dhugga) (herein "Property") has been determined to pose an impediment to the revitalization of the 6th Avenue Corridor; and

WHEREAS, the renovation of the Property was identified as a top priority in the planning process for the 6th Avenue Corridor, and by the Neighborhood Development Division of the City's Community Development Department; and

WHEREAS, 6th Avenue Corridor, Inc. ("6AC") proposes to acquire the Property, and to either complete the rehabilitation project itself or, with City staff, select a suitable for-profit or non-profit developer to purchase the property from 6AC, subject to affordability covenants and with purchase proceeds returned to the City as project income, for development of a future affordable multi-family housing project; and

WHEREAS, the City of Des Moines has allocated \$318,650 of Community Development Block Grant (CDBG) funding for fiscal year 2015 for Neighborhood Revitalization Plan Implementation; and

WHEREAS, the City proposes to utilize up to \$250,000 of such CDBG funding to assist 6AC in the above-described project to acquire and direct the rehabilitation of the historic property and for low-rent housing purposes, pursuant to the Neighborhood Revitalization Plan; and

WHEREAS, 6AC's proposed project for redevelopment of the Property is set forth in a CDBG Project Agreement between the City and 6AC, on file in the office of the City Clerk, and, due to the nature and amount of such Agreement, the Agreement is being presented to City Council for consideration and approval.

NOW THEREFORE, BE IT RESOLVED, by the City Council of the City of Des Moines, Iowa, that the CDBG Project Agreement between the City of Des Moines and 6th Avenue Corridor, Inc. for the acquisition of the property locally known as 1601-1605 6th Avenue (Anchulee Dhugga), as on file in the office of the City Clerk, is hereby approved; the City Manager is authorized and directed to execute said Agreement on behalf of the City; and the Community Development Director and his designee(s) are authorized and directed to administer said Agreement pursuant to its terms.
