APPROVING EXTENSION OF AGREEMENT WITH AIRPORT AUTHORITY

WHEREAS, the City provides services to the Des Moines Airport Authority pursuant to an Agreement dated November 1, 2011; and

WHEREAS, the Airport Authority terminated the Agreement effective October 31, 2016 with the intent of negotiating a new agreement to provide services; and

WHEREAS, the City and the Airport Authority are in the process of negotiating a new agreement, but are unlikely to finalize the terms of the agreement by October 31, 2016; and

WHEREAS, the Airport authority has requested an extension of the existing agreement for an additional month, to and including November 30, 2016, notwithstanding the termination date; and

WHEREAS, the City is willing to extend the existing agreement for an additional month to facilitate negotiations.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa that the attached Agreement is hereby approved and the Mayor is authorized and directed to execute the Amendment on behalf of the City.

AMENDMENT TO AGREEMENT BETWEEN THE CITY OF DES MOINES AND THE DES MOINES AIRPORT AUTHORITY FOR THE PROVISION OF CITY SERVICES

This Amendment is made as of the 18 day of 0ctober, 2016 by and between the City of Des Moines, Iowa, municipal corporation, and the State of Iowa (the "City") and the Des Moines Airport Authority, an airport authority organized under Iowa Code Chapter 330A (the "Authority").

WHEREAS, the City and the Authority entered into an Agreement between the City of Des Moines and the Des Moines Airport Authority for the provision of City services dated November 1, 2011 pursuant to which the City agreed to provide certain services to the Authority; and

WHEREAS, on October 28, 2015, the Authority notified the City of the termination of the Agreement pursuant to its terms effective October 31, 2016; and

WHEREAS, the City and the Authority are presently engaged in negotiations with the intent of entering into a new services agreement, but have not completed those negotiations; and

WHEREAS, both the City and the Authority require additional time to complete their negotiations.

THEREFORE, the parties agree as follows:

1. Article 1 of the Agreement is amended to state:

This agreement terminates on November 30, 2016.

2. In all other respects, the Agreement shall otherwise remain in full force and effect as amended in Supplement No. 2 dated February 15, 2016.
