WHEREAS, the low dollar compliant bids for ITEMS 1, 3 and 4 was received from Feld Fire, 113 N. Griffin Road, Carroll, IA 51401, John Feld, Owner; and

WHEREAS, the low dollar compliant bids for ITEM 2 was received from Municipal Emergency Services, 1880 East Military Ave., Fremont, NE 68025, Nicole Kingston, Manager; and

WHEREAS, funding is available from FD104113/Operations, for an annual estimated cost of \$66,000.00; and

WHEREAS, the Procurement Administrator and the Fire Department recommend approval of multiple awards for firefighting helmets, hoods, gloves and boots.

NOW THEREFORE BE IT RESOLVED, that the Des Moines City Council hereby accepts and approves the award to the aforementioned bidders, and further authorizes the Procurement Administrator to enter into annual agreements renewable for two (2) additional twelve (12) month periods, with price increases complying with agreement terms.
