## APPROVING AN AMENDMENT TO THE SCHEDULE OF FEES FOR REMOVAL OF FEES RELATED TO REPEAL OF ARTICE V OF CHAPTER 126 OF THE MUNICIPAL CODE

WHEREAS, Article V of Chapter 126 of the Municipal Code of the City of Des Moines concerning vehicles for hire has been repealed which requires removal of the associated fees previously set out at sections 126-232 and 126-235 from the Schedule of Fees; and

WHEREAS, an amendment to the Schedule of Fees removing the vehicle for hire fees has been prepared for Council consideration and is recommended for adoption, which amendment is appended hereto and is now on file in the office of the City Clerk;

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Des Moines, Iowa that the amendment to the Schedule of Fees appended hereto with the deletion of the fees associated with repealed Article V of Chapter 126 of the Municipal Code for the City of Des Moines is hereby approved and adopted.

**AND BE IT FURTHER RESOLVED** that the City Clerk is hereby authorized and directed to incorporate said amendment into the Schedule of Fees, and to maintain said Schedule of Fees, as amended, on file in the offices of the City Clerk for public reference.
