HOLD HEARING FOR CONVEYANCE OF AN UNDERGROUND ELECTRIC EASEMENT ON CITY-OWNED PROPERTY AT 7401 SW 9th STREET TO MIDAMERICAN ENERGY COMPANY FOR \$1

WHEREAS, an underground electric transmission line is needed across a portion of City-owned property located at 7401 SW 9th Street in order to provide electrical service to the Blank Park Zoo's new giraffe house located thereon, which property is currently being leased to Blank Park Zoo, and thus MidAmerican Energy Company has requested an underground electric easement ("Easement") across said City-owned property in consideration of \$1.00 and the utility service being provided therein; and

WHEREAS, the City of Des Moines, Iowa ("City"), must grant the easement in order to provide electrical service to the Blank Park Zoo's giraffe house, and the Blank Park Zoo consents to the City's grant of said Easement; and

WHEREAS, the City and the public will not be inconvenienced by the conveyance of said Easement as requested by MidAmerican Energy Company; and

WHEREAS, on November 21, 2016, by Roll Call No. 16-1993, it was duly resolved by the City Council of the City of Des Moines, Iowa, that the proposed conveyance of the Easement be set down for hearing on December 5, 2016, at 5:00 p.m., in the City Council Chambers; and

WHEREAS, due notice of the proposal to convey the Easement was given as provided by law, setting forth the time and place for hearing on the proposed conveyance; and

WHEREAS, in accordance with City Council direction, those interested in the proposed conveyance, both for and against, have been given an opportunity to be heard and have presented their views to the City Council.


NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:
