## SETTING DATE OF HEARING ON SECOND AMENDMENT TO LEASE AGREEMENT WITH SOUTH DES MOINES LITTLE LEAGUE FOR THE JAMES W. COWNIE BASEBALL PARK

WHEREAS, on April 9, 2007, by Roll Call No. 07-689, the City Council approved the Lease Agreement by and between the South Des Moines Little League (SDMLL) and on July 23, 2012, by Roll Call No. 12-1198, the City Council approved an Amendment to said Lease, for lease of James W. Cownie Baseball Park for the purpose of youth baseball or softball programs and play and other related purposes ("the Lease"); and

WHEREAS, under the Lease the South Des Moines Little League is required to pay \$60,000 annually as rental payment for lease of the Leased Premise; and

WHEREAS, the fees for use of the baseball tournament field rentals have been increased by the City in 2016 and the League has agreed to increase its annual rental payment amount to the City to correspond to such fee increase; and

WHEREAS, City staff have negotiated a Second Amendment to Lease Agreement which provides for an annual rental increase from \$60,000 to \$70,000 effective September 1, 2017, a copy of which is on file in the City Clerk's Office; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Des Moines, Iowa, that:

1. The City Council of the City of Des Moines shall consider a Second Amendment to Lease Agreement by and between the City and South Des Moines Little League of the James W. Cownie Baseball Park, located at 2050 SE 22<sup>nd</sup> Street, Des Moines, Iowa, to change the consideration from an annual rental of \$60,000 to \$70,000 effective September 1, 2017.

2. A public hearing shall be held on March 6, 2017 at 5:00 pm in the City Council Chamber, Richard A. Clark Municipal Service Center, 1551 E. Martin Luther King, Jr. Parkway, Des Moines, Iowa.

3. The City Clerk is authorized and directed to publish notice of the proposal and hearing in the form hereto attached not less than four or more than twenty days from the date of the hearing.
