\$ 551,765.75

BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF DES MOINES, IOWA: That the contract and bond, in the amount of \$551,765.75, executed by T K Concrete Inc., Tony J. Ver Meer, President, 1608 Fifield Road, Pella, IA, 50219 dated February 20, 2017, for the construction of the following improvement:

Park Avenue Elementary Pedestrian Bridge Removal and Site Improvements, 04-2017-002

The improvement includes the removal of a pedestrian bridge over S.W. 9th Street near Park Avenue and the southbound right-turn lane on S.W. 9th Street, construction of Portland Concrete Cement (PCC) on-street parking insets, curb and gutter, sidewalks and curb ramps, segmental block retaining walls, fencing, and concrete steps, together with the necessary removals, earthwork, clearing and grubbing, erosion control, storm sewers, traffic control and incidental items; all in accordance with the contract documents, including Plan File Nos. 578-063/117, along S.W. 9th Street, Park Avenue, and S.W. 7th Street near Park Avenue Elementary School, Des Moines, Iowa

the same to be performed in accordance with the plans and specifications which have been heretofore approved by this Council, be and the same are hereby approved, subject to receipt of the contract, bond, and certificate of insurance acceptable to the Engineering and Legal Departments. The attached "Contractor's Anticipated DBE/TSB Utilization" shows the Contractor's efforts to solicit DBE/TSB Participation in accordance with the Disadvantaged Business Enterprise/Targeted Small Business (DBE/TSB) Program.

BE IT FURTHER RESOLVED: That the Mayor be and is hereby authorized and directed to execute said contract on behalf of the City of Des Moines, subject to receipt of the contract, bond, and certificate of insurance acceptable to the Engineering and Legal Departments, and the City Clerk, be and is hereby authorized and directed to attest to same. No contract shall be deemed to exist between the City of Des Moines and said Bidder until said contract has been executed by the Bidder, and shall have been approved by this Council and executed by the Mayor and attested to by the City Clerk.

BE IT FURTHER RESOLVED: That after said contract has been executed by the Mayor, the City Clerk be and is hereby authorized and directed to return the Contractor's bid security.

BE IT FURTHER RESOLVED: That the attached Permission to Sublet form, from said Contractor requesting permission to sublet designated items, be and is hereby approved, subject to receipt of the contract, bond, and certificate of insurance acceptable to the Engineering and Legal Departments; and each subcontractor is hereby granted permission to work on said improvement.


