CONTINUATION OF PUBLIC HEARING, APPROVING PLANS, SPECIFICATIONS, FORM OF CONTRACT DOCUMENTS, AND ENGINEER'S ESTIMATE ON WALNUT STREET BUS LANE FROM 9TH STREET TO 10TH STREET;

WHEREAS, on January 9, 2017, under Roll Call No. 17-0008, plans, specifications, form of contract documents, and Engineer's estimate of construction cost were filed with the City Clerk, for the construction of the following improvement:

Walnut Street Bus Lane from 9th Street to 10th Street, 04-2017-001

The improvement includes construction of sidewalks, Portland Cement Concrete (PCC) curb and pavement, and Hot Mix Asphalt (HMA) pavement overlay, together with the necessary removals, clearing and grubbing, traffic control; all in accordance with the contract documents, including Plan File Nos. 578-016/036, on Walnut Street from 9th Street to 10th Street, Des Moines, Iowa

WHEREAS, notice of the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost was published as required by law.

WHEREAS, the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement and the designation of lowest responsive, responsible bidder was continued from the February 6, 2017 City Council meeting.

WHEREAS, the City Engineer has requested that the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement and the designation of lowest responsive, responsible bidder be continued to the March 20, 2017 City Council meeting.

NOW THEREFORE BE IT RESOLVED, that the City Council of Des Moines, Iowa, that it hereby continues the hearing on the plans, specifications, form of contract documents, and Engineer's estimate of construction cost for said improvement and the designation of lowest responsive, responsible bidder to the March 20, 2017 City Council meeting.


