**HEARING AND ADOPTION OF AMENDED MUNICIPAL HOUSING AGENCY
ANNUAL BUDGET FOR THE FISCAL YEAR ENDING JUNE 30, 2017**

WHEREAS, on February 20, 2017, by Roll Call No. 17-0237, the Municipal Housing Governing Board set the public hearing to consider the Municipal Housing Agency's amended annual budget for the fiscal year ending June 30, 2017 for March 6, 2017, at 4:15 o'clock p.m., in the Council Chambers in the Municipal Service Center, 1551 East M.L. King Parkway and public notice of such hearing was published as provided by law in the Des Moines Register on February 23, 2017; and



NOW, THEREFORE, BE IT RESOLVED by the Municipal Housing Governing Board that:

1. The publication of notice of the hearing on February 23, 2017 is hereby ratified.
2. Upon due consideration of all views and comments presented by residents and taxpayers of the City or the area of operation of the Agency, the public hearing on the Municipal Housing Agency's amended annual budget for fiscal year ending June 30, 2017 is hereby closed.
3. The Municipal Housing Agency's amended annual budget for the fiscal year ending June 30, 2017, as set forth in the operating budget document on file with the City Clerk is hereby approved and adopted.
4. The Mayor and City Clerk are hereby directed to execute and to certify the Municipal Housing Agency's amended budget for the fiscal year ending June 30, 2017 to the Des Moines City Council for incorporation into the City's fiscal year 2017 amended budget to be certified to the State of Iowa.
