

Dear Mayor Cownie and City Council members,

Request 1: Why didn't the City Council hold a public forum with formal vote prior to directing taxpayer-funded lobbyists to register support or opposition of proposed legislation? This lack of transparency could result in long lasting financial, environmental and public health damage. It is also disturbing that the City Council has not openly made its case in a public forum about proposed legislative options. The process is flawed.

I am a Ward 3 resident and I deeply oppose HF 484. Des Moines needs Water Works, and needs it to remain under the oversight of an independent board that considers the best science and practices as it holds itself accountable to the citizens of Des Moines. I am grateful to Bill Stowe for the way he has worked to protect water quality, and I am deeply disturbed by what I have heard about this bill, from multiple sources--that it is written as "payback" for the lawsuit brought against corporate agriculture entities which have polluted so many of our waterways. I am mystified as to why the city would register itself as in support of this bill, as it jeopardizes our water and threatens to appropriate taxpayer-owned land and facilities.
