ORDINANCE NO.	

AN ORDINANCE vacating a portion of Mulberry Street and 12<sup>th</sup> Street rights-of-way adjoining 121 12<sup>th</sup> Street.

WHEREAS, all prior requirements of law pertaining to the vacation of public right-of-way have been fully observed; and

WHEREAS, it is desirable that the public right-of-way herein described be vacated;

NOW, THEREFORE, BE IT ORDAINED by the City Council of the City of Des Moines, Iowa:

Sec. 1. That a portion of Mulberry Street and 12<sup>th</sup> Street rights-of-way adjoining 121 12<sup>th</sup> Street, more specifically described as follows, be and is hereby vacated:

## 12th Street

Commencing at the Northwest corner of said Block 23 of KEENE & POINDEXTER'S ADDITION TO FORT DES MOINES; thence South 15°26'05" East, 67.17 feet along the East right-of-way line of said 12<sup>th</sup> Street, also being West line of said Block 23, to the Point of Beginning; thence continuing South 15°26'05" East, 5.00 feet along the East right-of-way line of said 12<sup>th</sup> Street; thence South 74°33'55" West, 5.00 feet; thence North 15°26'05" West, 5.00 feet; thence North 74°33'55" East, 5.00 feet to the point of beginning.

Containing 25.00 square feet.

## Mulberry Street
