Description: The Traffic Safety Committee is an advisory body to the City Council. The Committee meeting agenda regularly contains a wide variety of traffic and parking concerns, with an emphasis on school crossings, neighborhood traffic, and other transportation safety issues.

One member shall be appointed by the Superintendent of the Des Moines Independent Community School District to represent the interest of the schools citywide.. The term of office of the eight appointed members shall be staggered terms of three years. Expiration of all terms of appointed members shall be December 31. Each member of the City Council may recommend a candidate to fill one position on the board. Notwithstanding Section 2-1059 regarding term limits, members may be reappointed for a third or consecutive term. Ordinance 15,528, Roll Call 16-1923- November 7, 2016.
