RESOLUTION AUTHORIZING AND APPROVING PARTIAL ABANDONMENT AND RELEASE OF PUBLIC UTILITY EASEMENT IN PROPERTY LOCATED NORTH OF DES MOINES STREET BETWEEN EAST 2ND STREET AND EAST 4TH STREET
