ORDINANCE NO.

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2088, 114-2091, 114-2179, 114-3345 and 114-3625, and by adding and enacting new Section 114-2088.05, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2088, 114-2091, 114-2179, 114-3345 and 114-3625, and by adding and enacting new Section 114-2088.05, relating to traffic and vehicle regulations, as follows:

Sec. 114-2088. East Thirty-third Street.

East Thirty-third Street, from the north line of East University Avenue to the south line of East Euclid Avenue, stop.

East Thirty-third Street, at East Court Avenue, stop.

Sec. 114-2088.05. Southeast Thirty-third Street.

Southeast Thirty-third Street, at East Court Avenue, stop.

Sec. 114-2091. East Thirty-fourth Street.

<u>East Thirty-fourth Street, at East Court Avenue, stop.</u> East Thirty-fourth Street, at Thompson Avenue, stop.

Sec. 114-2179. East Court Avenue.

East Court Avenue, from the middle of the Court Avenue Bridge over the Des Moines River to the east line of East Sixteenth Court, stop.

East Court Avenue, at East Thirty-second Court Avenue/Southeast Thirty-second Court Avenue, stop.

East Court Avenue, at East Thirty-third Court Avenue/Southeast Thirty-third Court Avenue stop.
