

AN ORDINANCE to amend the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, by amending Sections 114-2088, 114-2091, 114-2179, 114-3345 and 114-3625, and by adding and enacting new Section 114-2088.05, relating to traffic and vehicle regulations.

Be It Ordained by the City Council of the City of Des Moines, Iowa:

Section 1. That the Municipal Code of the City of Des Moines, Iowa, 2000, adopted by Ordinance No. 13,827, passed June 5, 2000, as heretofore amended, is hereby amended by amending Sections 114-2088, 114-2091, 114-2179, 114-3345 and 114-3625, and by adding and enacting new Section 114-2088.05, relating to traffic and vehicle regulations, as follows:

**Sec. 114-2088. East Thirty-third Street.**

East Thirty-third Street, from the north line of East University Avenue to the south line of East Euclid Avenue, stop.

East Thirty-third Street, at East Court Avenue, stop.

**Sec. 114-2088.05. Southeast Thirty-third Street.**

Southeast Thirty-third Street, at East Court Avenue, stop.

**Sec. 114-2091. East Thirty-fourth Street.**

East Thirty-fourth Street, at East Court Avenue, stop.

East Thirty-fourth Street, at Thompson Avenue, stop.

**Sec. 114-2179. East Court Avenue.**

East Court Avenue, from the middle of the Court Avenue Bridge over the Des Moines River to the east line of East Sixteenth Court, stop.

East Court Avenue, at East Thirty-second Court Avenue/Southeast Thirty-second Court Avenue, stop.

East Court Avenue, at East Thirty-third Court Avenue/Southeast Thirty-third Court Avenue stop.

**Sec. 114-3345. Ingersoll Avenue--Thirty-fifth Street to Fifty-ninth Street.**

Ingersoll Avenue, on the south side, from Thirty-fifth Street west for a distance of 130 feet, no parking any time.

Ingersoll Avenue, on the south side, from a point 130 feet west of Thirty-fifth Street to a point ~~130~~ 345 feet west of Thirty-sixth Street, two-hour parking 9:00 a.m. to 4:00 p.m.

Scott Avenue, on the north side, from Southeast Twenty-fifth Court to Southeast Twenty-seventh Street, no parking any time.


Scott Avenue, on the north side, from Southeast Twenty-seventh Street to Southeast Twenty-seventh Court, no parking any time.

Scott Avenue, on the north side, from a point 50 feet east of Southeast Thirtieth Street to the east city limits, no parking any time.
